# **Payment Due Date and Late Fee Policy**

- Your payments are due on either the 1st or 15th of every month. If you do not choose a payment
  due date, Enagic will pick the due date for you. The first payment date must fall within a 45-day
  period of the date of purchase.
- For UKON customers, the monthly due date is the same as the original purchase date.
  - The UKON DD Auto-renewal date is exactly 4 months after your original purchase date.
  - The UKON Sigma Auto-renewal date is exactly 12 months after your original purchase date.
- Enagic USA will automatically renew Ukon Auto-ship accounts at the end of each term unless an Ukon Cancellation Form is submitted no later than (5) business days prior to your next scheduled renewal date.
- A late fee of \$20 per month will be applied to your account every time you miss a payment.
- The Ukon account will be terminated if your payment is more than 10 days late.

### **Automatic Withdrawal**

 Setting up your account for automatic withdrawal does not always guarantee that your payment will go through. It is your responsibility to keep track of your payments.
